### **General Instructions**

1. Filled-in Applications should be sent to The Director of Research and Publications, SCSVMV, Enathur, Kanchipuram - 631561 on or before the due date, along with a Demand Draft for Rs.1000/- (Rs.500/- in case of Sanskrit/Tamil/Hindi or SC/ST or Physically/Visually Challenged applicants) drawn in any nationalized / scheduled bank payable at Chennai/Kanchipuram, strictly in favor of The Registrar, SCSVMV
2. Acknowledgement for the receipt of application will be sent by sms / mail to the applicant's mobile number / email id along with the application number assigned. Applicant can also check the status of his/her application on our website with the application number. No correspondence will be entertained in this regard.
3. Applicants should ensure that the application is complete in all respects with the aid of the check list given along with the application. Self attested copies of certificates must be attached in the order mentioned in the Checklist. Incomplete applications / Applications without required enclosures / Applications opting for an external Guide will be summarily rejected and no enquiries / communications will be entertained in this regard.
4. Updated and signed Curriculum Vitae of Applicant should be attached with the application.
5. A detailed research proposal with relevant literature survey must be attached with the application, which will be helpful while scrutinizing the applications.
6. Part time applicants should attach a No Objection Certificate from the employer. Self Employed Professionals should attach a Self Declaration in this regard.
7. Applicant need not opt or select an internal guide. If selected at the entrance test and interview Viswa Mahavidyalaya will assign guides to selected applicants.

If selected in the initial scrutiny, the applicant will be called to appear for an entrance test followed by a technical interview at the Viswa Mahavidyalaya Campus on the date and time specified by Viswa Mahavidyalaya. Intimation will be sent to the e-mail id / mobile number and will also be posted on our web page. All the original certificates, documents, M.Phil dissertation etc cited in the application must be produced at the time of interview which will be returned after physical verification.
